Preparation for AGM - Tuesday 9 April @ 12pm

- I. <u>Karakia</u> M Devon stated an action point from the last Executive meeting was to identify key karakia that could be used by the Association. M Devon tabled four karakia for the Executive to consider. P Noble gave the Executive an overview of the purpose of each karakia. O Murray informed that the Executive that 'Whakataka te hau' was an inclusive option as it could be communicated in NZ sign language. Executive to confirm their preferred karakia at the next Executive meeting. M Devon stated that karakia would be included as part of the AGM.
- II. <u>Mihi/Welcome</u> M Devon stated that due to time restraints a full round of introductions was not possible however she wished to welcome Peng Xing to the meeting and asked if he could briefly introduce himself to the Executive.
- III. Purpose of the AGM M Devon asked A Hart to give the Executive an overview of the purpose of the AGM. A Hart tabled the Constitution clauses relating to the AGM and stated that the key purpose of the AGM was to: report on the previous financial year including the service performance report and annual accounts; appoint an Auditor for 2024; run an Executive election for any available positions.

A Hart said that at SGM in October 2023 the Association had stated with the uncertainty surrounding Te Pükenga and any funding implications, that an update would be provided to the student body at AGM 2024.

2024 Budget review and recommendations for AGM

A Hart stated that the Association would receive \$146,000 less funding for the 2024 SLA (compared to the 2023 SLA). A review of the 2024 budget had taken place to identify any areas for potential savings. A Hart also stated that NMIT was open to reviewing the 2024 funding in May 2024.

Reviewed budget was tabled for discussion. Executive did not wish to see hardship and event reduced. Executive to recommend that additional funds to be approved from saving at AGM cover these core service provision.

Motion: That an additional \$49,000 is approved from savings to support the delivery of the 2024 Strategic and Operational plan.
