- (c) A person is disqualified from being an Officer if they are disqualified under section 47 of the Incorporated Societies Act 2022 or section 16 of the Charities Act 2005.
- (d) The Association must notify the Registrar of any change in its Officers as required by the Act.

- (e) The decision of the arbitrator (or a resolution reached in mediation) is final and binding on all members and Officers of the Association.
