Representation

S Bailey stated that Executive needed to revisit SANITI's student representative commitments at both a national and Institute level. SANITI Office Relocation

S Bailey stated that NMIT had informed SANITI that N Block Kōwhai Lounge and the current SANITI offices are to be repurposed for academic delivery. Current plan is for the area to be redeveloped in 2nd Semester 2025, for academic delivery in 1st Semester 2026.

S Bailey tabled an email from NMIT Director Nicole Akuhata and the floor plan for the bottom floor of L Block. S Bailey stated that at the end of the meeting the Executive could visit the L Block space.

Executive expressed concern at the Student Centre being repurposed as an academic space as it was at the centre of the campus and a popular space for students to congregate. S Islam stated she was not supportive of the relocation from a student's point of view. S Islam raised concern that L Block looked closed every time she walked past, that SANITI's current space was welcoming to students, and that there would need to be a welcoming entrance made into the L Block space.

S Bailey stated that NMIT was proposing to open other spaces for students and that the Executive would have an opportunity to address their questions to the NMIT Executive Director Olivia Hall at the Executive meeting on Wednesday 18 June 2025.
